About Give2SF: The Give2SF COVID-19 Response and Recovery Fund is a special fund established by the City and County of San Francisco as part of the Second Supplement to Mayoral Proclamation "Declaring the Existence of a Local Emergency" issued on March 13, 2020. Donations accepted "may be expended by the City to provide shelter, food, financial assistance including but not limited to loans, grants, or rent, mortgage and utility payments, and other assistance to individuals and families in the City who are impacted by the emergency; to replace, repair, and rebuild public buildings, infrastructure, and other assets for use in the City's efforts to respond to the emergency; to issue and administer grants and/or interest-free loans to small businesses in the City to compensate for economic harms resulting from COVID-19; and for other City efforts to address the impacts of COVID-19."
