Is the work expected to be in-person?	TA & CB support is expected to be virtual and is subject to change depending on the needs of DCYF

Do we need to include pricing for our workshops and other services, or will that be negotiated if a contract is initiated?	You do not need to include pricing for workshops in the RFQ. Negotiation of costs will take place if DCYF selects you as a potential provider.

Can you provide more details about what is expected for the Critical Agency Support?	Critical Agency Support is either programmatic or fiscal support that can range from coaching and/or tailored workshops to support specific agency's needs. This body of work is at minimum 3-6 months.
What kinds of services are you looking for, or what services have historically been needed for this program?	Under the Critical Agency Support, we are looking for services that cover Board Development, Fiscal Analysis, Accounting, Executive Director transitions.
Who is the audience for this program? Direct service providers, administration, both, or other?	We provide trainings/workshops and/or coaching for multiple audiences. The audience also depends on the structure of the organization and any conversation between DCYF and the organization.

Question	Answer
How many classes constitute a course?	Prior to the pandemic a course ranged from 8-10 courses that were either half-day or full day. Currently, 6 classes constitute a course. A virtual module ranges from 20-30 hours.
Will one course be provided by one agency, or might DCYF combine multiple agency offerings into one course?	One agency can provide a course. Depending on the topic and the area of expertise from the agency, DCYF can combine agencies to work on a course.

Seeing that DCYF University will offer credit through SF State, do you allow providers you work with to partner with other universities to offer additional university credits to participants? For context, we have long partnered with the USF School of Education on a professional development series for classroom educators that also earned teachers' college credits from USF upon completion. What is the process for establishing a cohort? What supports does DCYF provide? Are there specific expectations for how many sessions a cohort may meet?	Cohort design is created in collaboration with DCYF's Technical Assistance and Capacity Building Team	
Are experiential trainings welcome? This would be where participants get to fully experience what it is like to be a student then receive a breakdown of the practices, techniques, and pedagogical underpinnings so they may incorporate it into their practice with youth. Or are lectures and presentations preferred.	Experiential Trainings, Lectures and Presentations are welcomed.

3. If we do not intend to hire any subcontractors, are we still required to meet the "Good Faith Outreach" requirements?	In the event that an LBE requirement is set on a project issued by this RFQ, proposers will be required to comply with the Good Faith Outreach requirements.
